Internal Affairs

- We discussed the upcoming late-night breakfast scheduled for December 8, where students will have the opportunity to enjoy breakfast at night in the SUB while studying for their finals. The executives and Councillors are expected to be present to enhance the student experience during this event.
- One-onOne with the General Manager Ongoing
 - I maintain a regular practice of conducting one-on-one meetings with the General Manager to address staff concerns and ensure a comfortable living environment for everyone. Additionally, we discuss a wide range of other topics pertinent to the DSU's well-being and efficiency.
- DSU x DalOut x Loaded Ladle November 29, 2023
 - O In my recent meeting with DalOut and the LL, we addressed concerns, particularly focusing on the space allocation issue and establishing more effective communication strategies. The society members expressed great satisfaction with the meeting, feeling genuinely heard, and noted that it was the first time they were invited to discuss such matters with the President.

 - I presented and gained approval for the funding of my project to name the exterior of the building.

- DSU Exec/VPEI Meeting November 22, 2023
 - We had a meeting with the Dalhousie Equity and Inclusion Office to discuss various matters, during which my focus was on the Palestine and Israel concerning events. Our objective was to explore ways to provide optimal support for our students navigating these sensitive issues.
- DSU Exec/SA Meeting November 23, 2023
 - We had our meeting with Dalhousie Student Affairs covering a range of topics crucial to the student experience.
- Meeting with Leslie Phillmore November 27, 2023
 - Met with the Associate Vice-President Academics, Lislie, to further discuss my
 COOP efforts, seeking her insights and expertise to enhance our initiatives.
- Dalhousie Senate Meeting November 27, 2023
 - I participated in the regular Senate meetings with the university, where discussions revolved around key academic and administrative matters.
- DSU x ISC November 28, 2023
 - Our recent meeting with the Indigenous Office centred on our commitment to integrating Indigenous culture into the DSU and our operational practices.
 Discussions included planning upcoming semester events and exploring the possibility of providing annual Indigenous knowledge training for our Executives to foster a more inclusive environment.
- Dalhousie Board of Governors Meeting November 28, 2023
 - I attended the Dalhousie Board of Governors meeting, presenting my regular report to provide the university with updates on our DSU.
- Dalhousie Board of Governors Annual Dinner November 28, 2023
 - I was invited to the Dalhousie Board of Governors' annual dinner, where ou
 Student Union received significant praise for our exemplary work thus far. It was
 a wonderful opportunity to celebrate our accomplishments and strengthen
 connections within the university community.
- Code of Conduct Task Force Ongoing
 - I continue to collaborate with DAL as a member of the Code of Student Conduct
 Task Force. We are currently visiting the guiding principles set forth by the

- Integrated Policy Framework Advisory Group. Our focus is on the development and review of policies that govern community behavior.
- Dalhousie Alcohol Advisory Committee Meeting December 4, 2023
 - Participated in a meeting with the Alcohol Advisory Committee to engage in discussions regarding the new alcohol policy and approve proposed amendments, including the incorporation of guidelines related to cannabis.
- By-Weekly Meetings with Vice-Provost of Student Affairs December 4, 2023
 - I had the usual bi-weekly meeting with Rick to discuss ongoing matters and collaborate on initiatives aimed at enhancing the student experience.

External and Broader Community

- Giving Tuesday Ongoing
 - o In just one year, visits to the DSU food bank by international students have surged from 282 to 839 per month, with an increase in visits from Master's level students, with an additional 200 students seeking support monthly over the past year.
 - o In line with our commitment to community welfare, I am excited to share news about our fourth annual Giving Tuesday campaign for the DSU Food Bank that happened on November 28th, 2023. This initiative is crucial for supporting food banks in Halifax and Truro. Our title sponsor, the J & W Murphy Foundation, generously matches up to \$20,000 of funds raised at Dalhousie.
 - This year, our collective efforts have already amassed over \$67,000. And notably, this campaign extends beyond Dalhousie, benefiting post-secondary universities across Nova Scotia.
 - The General Manager and I had a debrief session with Clare from the Advancement Office to evaluate the project's progress and explore avenues for improvement in the upcoming year, possibly extending our collaboration to include governmental figures. The aim is to enhance the project's effectiveness and broaden its impact through strategic refinements and expanded partnerships.
- The Canadian Alliance of Student Associations Advocacy Week November 20-November 24, 2023

- O During the recent CASA advocacy week in Ottawa, the VPSL and I actively engaged with MPs, ministers, and other governmental figures throughout the week, advocating for various student issues on a federal level. The enthusiasm displayed by these individuals was promising, and we are eagerly anticipating the follow-ups. My particular focus during these discussions centred on addressing pressing concerns related to housing, and tuition and health insurance for international students, which are significant issues on our campus.
- Provincial Sexual Violence Prevention Committee November 27, 2023
 - I attended the PSVPC meeting, where discussions centered on developing strategies and initiatives to address and prevent sexual violence. The committee's collaborative efforts aim to contribute to broader efforts in fostering a safer environment for all. My lens focused on the unique challenges and opportunities present within our campus community.
- Meeting with the Ombudsperson November 29, 2023
 - O I convened with Ombudsperson Carla to discuss her annual evaluation report on the DSU and address specific concerns raised within the document. The meeting provided an opportunity to engage in a constructive dialogue, seeking clarity on the report and working collaboratively to address any identified issues.
- Government-Student Roundtable December 4, 2023
 - During the student-government roundtable, I delivered a brief presentation
 providing updates on various campus matters, with a particular focus on
 addressing the pressing food security issue. I sought the attention of the
 government to address and prioritize this critical concern impacting our student
 community.

NSPIRG was ratified via e-vote on November 23.

Offices Steering Committee Updates

After conversations with the General Manager and the Policy and Governance Coordinator, we realized that the Committee is not listed in any of our governing documents. After investigating the matter, I discovered that the Committee Policy, the only place where the Offices Steering Committee was outlined, was revoked on May 22, 2019. The PGC found the temporary bylaw amendments from 2019 passed at Council that added the OSC to the list of standing DSU Committees for one year (due to lack of AGM quorum), but after 2020, no attempt to legitimize

the Committee was made. After conversations between the General Manager, PGC, and the Executive Committee, the executive passed a motion on December 1st stating that the work of the OSC can be done more efficiently and with better supervision and accountability if the steering was conducted by the newly hired Advocacy and Research Coordinator, and budget approvals by the approval bodies outlined in the Financial Policy.
